4. EMSA President Report

EMSA President and CEO Jim Winham reviewed EMSA compliance for June and July 2021 in the Eastern and Western Divisions. Mr. Winham cited staffing, hospital bed delays, and the COVID pandemic as stressors against desired compliance. Mr. Winham discussed that EMSA continues to face a national shortage of qualified paramedics. Mr. Winham cited progress in the utilization of off-duty OKCFD paramedics to staff EMSA ambulances in that 26 of the 66 volunteers to work part-time at EMSA had completed transport duty training. He indicated to the MCB that EMSA will be meeting weekly with hospital Chief Nursing Officers and Chief Medical Officers to discuss hospital bed delays. Mr. Winham stated that EMSA is spending approximately \$40,000 monthly on Transfer of Care paramedics in area EDs. He summed the collective of EMSA actions as "We are going to do the best that we can."

5. Chief Medical Officer/Associate Chief Medical Officer Reports

Dr. Goodloe updated the MCB on the status of the 911 BLS Ambulance Program, addressing holding the discussion with the Tulsa City Council to address concerns of the Tulsa firefighters union by EMSA. In Oklahoma City, Drs. Goodloe and Knoles and David Howerton met with City Manager Craig Freeman and Assistant City Manager Ken Tsoodle to brief them on the patient safety clinical analysis that is the basis of MCB/OMD continuing support for the program. In response to further questions from the MCB, Dr. Goodloe assured the MCB it has taken all necessary action for the program to progress and that remaining steps are within EMSA and the city councils for the necessary ordinance changes to occur.

Dr. Goodloe referenced the "window of opportunity" that is upcoming in which both the City of Oklahoma City and the City of Tulsa take such time to with re-affirm the present infrastructure of the EMS system or request alternate structure bids. Dr. Goodloe reassured the MCB that he and the entirety of the OMD team continue in focus on clinical support of the EMS system. He addressed rumors that he and the OMD team are working in concert with fire departments to "take over" the EMS system and categorized such statements as factually false and slanderous to the independence of medical oversight in the EMS system.

6. Review and Approval of 2022 MCB Treatment Protocols

Dr. Goodloe briefed the MCB that due to the cumulative stress on operations in the EMS system at present, desired clinical protocol changes are being held at this time. The OMD team did comprehensively review the peer-reviewed, published literature germane to EMS protocols that was published within the past year and have added several citations to further support the existing protocols to become the 2022 MCB Treatment Protocols effective January 17, 2022.
